1. Plans presently are to run the market from May 21, June 18, July 16, Aug. 20, Sept. 17, 2011, at the T.P.A. Park in Frankfort, Indiana (please see www.hoosiersmarket.com for directions to the park, if you do not have Internet access please contact us at 765-659-0773 or 866-659-0773).
2. The Market will be every (3rd) Saturday of the month, May through Sept.
3. Set-up time will start at 5 AM on the Saturday morning of the event. No setting up prior to 5 AM.
4. The Market will be open for customers from 8 A M till 4 PM
5. Booth Space will be 20 X 20 foot, no tables or chairs are provided. Do not use picnic tables in the area.
6. Booth space will rent for \$20.00 for the day.
7. 2 booth spaces rent at \$17.50 each for the day.
8. Booths requiring electricity will be set up in designated areas and will be charged an additional \$15.00 per day.
9. You must provide your own extension cords and they must be UL Rated for outdoor use.
10. Booths must have at least (8) eight feet of space between the booth and any road.
11. Booth Spaces are both reserved & non-reserved, booths will be assigned on first come first served basis if not reserved. (Reserved spaces will be given priority on easy of parking and access, roadside booths, non-reserved booths will be limited to areas that are left after reserved booth).
12. Vendors must be set up by no later than 8 AM on the day of the Market.
13. No packing up prior to the 4 PM closing time. Vendors packing up prior to this time will forfeit their booth space for future Market dates. (Emergencies are the exception to this policy.)
14. **PARKING:** Parking will be permitted on the grass next to your booth when conditions permit. If the ground is soft due to rain, you will be required to park your vehicles in the parking places located throughout the park. Always use caution when driving on the grass at the park.
15. All spaces must be cleaned prior to leaving for the day, trash must be disposed of in containers provided.
16. **SHELTER HOUSES:** Please do not set up within 30 feet of any of the shelter houses, the shelter houses are rented during the summer for other functions.
17. No nails / staples / or other type of attachment items may be placed on any surfaces of the park.
18. Sale items placed on ground must be within the size limit of your booth.
19. No sales of firearms, pornography, indecent items, pets, alcoholic beverages, fireworks will be allowed. We also reserve the right to prohibit the sale of any item that may be questionable.
20. Alcoholic beverages are not allowed on the property of the TPA Park.
21. You must provide your own change, bags, and paper to wrap fragile items in.
22. You are responsible for any children you bring with you.
23. We are not responsible for any items stolen, damaged, or otherwise made unavailable for sale.
24. No misrepresentation of an item will be allowed.
25. Courtesy must be extended to all concerned.
26. Rules not being followed may result in you being asked to leave.
27. **Sales Tax:** If applicable, is the responsibility of the individual vendor to collect and report.
28. We reserve the right to make the final judgement on any policy covered or not covered in the above.
29. No edged weapons are to sold, including knives, swords, axes, straight razors, etc...
30. No items that you brought to be sold may be left in any area of the park upon your leaving. Boxes and trash must be disposed of in trashcans provided.
